#### **248-25 6. NEW PLAY AREA**

Abermule Recreation Association wish to progress with grant application to the National Lottery, by Community Council as play area in front of Abermule School, lease in Council's name and would benefit from Council reclaiming VAT. Council previously agreed to the removal of a tree, for safety reasons. Revised quotes from the preferred Contractor Complan, have now been received for two paths to the play area, one which would allow better access is circa £9352 (blue on plan) and the other is shorter and circa £3000 (grey on plan). Consideration was given to including to just the blue path, at an additional cost of circa £6000. Funds raised to date are £1,800 (with additional funding promised if the scheme goes ahead.)

Use of Council reserves would be necessary to advance this scheme, and therefore a finance meeting is required before the next council meeting. Council could look to requesting funds in the 2026/27 precept. The frequency of payments from National Lottery and payments to the Contractor must be a consideration as Council would need to pay VAT before reclaiming.

**RESOLVED** to hold a Finance meeting and report to Council prior to the meeting in September.

#### 249-25 PRE-SCHOOL AND AFTER SCHOOL PROVISION ABERMULE

Cllr. Meredith-Jones addressed council. Busy Bees operated a nursery and after school club is ceasing to trade. This may have a negative impact on school roll numbers. The Governors are looking to provide an after-school club this year and to consider a nursery in the following school year. A sum of up to £2,500.00 was allocated by this council to enable this project to commence. A business plan and cash flow forecast, which shows a profit, was presented to Council (based on 10 children and 2 staff members). Another member of staff would cover for sickness. Fees would be paid in advance. Consideration is being given to operate as a Community Interest Company with a board of Trustees, which is separate from Abermule School. An initial funding grant of £1,500 would be required and the further £1,000 to be considered when the scheme has been operating for at least three months.

Cllrs queried. Cash Flow figures presented did not take School holidays into account and were staff to be paid holidays?

RESOLVED to award £1,500 initially and the remaining £1,000 reviewed at our November meeting.

This council would like this to be a condition of the planning permission if granted.
