#### UPDATE FROM YOUR COUNTY COUNCILLOR

Post Services for Abermule. It is with some pleasure that I can report that Post Office Services are to return to Abermule in late March. The service will be by way of a Post Office van which will park on the roadside close to the Bus Stop. The service will be available on Monday's and Thursdays between 2.30pm and 3.30pm. Unfortunately at time of writing this update I do not have to hand the actual starting date, but when I do I will ensure that posters are displayed in the village when the actual date is known. I are confident that residents will welcome the return of this service and support it accordingly.

Abermule Industrial Park. I reported back in late 2015 that at last things were moving on taking forward commercial development on this site. Plans have changed somewhat and the plan now is for Powys County Council to take forward the development of the site and not Welsh Government. Plans have been drawn up which will see a phased development of possibly 24 units on the site along with a Powys County Council presence. The Capital Funding required for the project was contained within the Capital Strategy (part of the Councils budget) which I successfully took through Council on 25th February. It is now a matter of finalising the legal agreement with WG, which will then allow us to move forward with the project. Taking forward development in this way, removes the BREEAM EXCELLENT requirement for construction required by Welsh Government, which has proved a long term barrier to development on this site.

**Powys CC Budget.** On 25<sup>th</sup> February the County Council agreed the 3 year balanced budget plan for 2016/2019, which in total provides £29.8 million of savings over the 3 years. By the end of current year, the Council will have saved £53million and therefore this 3 year budget will take total savings for the period since 2012 to £83million. The 3 year plan is a plan for change, to try and preserve all front line services, although many will be delivered in a different way and also by different organisations. It is expected that for the year following this 3 year plan (2019/20) the Council will have to save another £7/8 million, but if the agreed 3 year plan is delivered successfully, it should cover the Council for the fourth year also. Although Council Tax for 2016/17 does not get agreed by Council until March 9<sup>th</sup>, the indicative Council Tax level in the budget passed by Council on 25<sup>th</sup> February is an increase of 4.25%. I will provide a full explanation as to why that level of increase is required in the April issue.

#### **NEWS FROM the COMMUNITY COUNCIL**

The Council has recently set its household precept for 2016/17. We are mindful of the general level of Council Tax and have aimed to keep increases to a minimum and in line with the services and facilities which the community survey told us were valued. Full details of what the precept provides for the community will be available on the website shortly. We have allocated:

- an increased grant to the two community centres to assist as all Powys CC funding is removed over the next two years
- an increase to small grants money available to groups and organisations following the successful pilot in 2015;
- a budget for 'street scene' services which we are likely to have to take over from Powys CC (working with Vale of Montgomery Cluster for economies of scale)
- a small increase for regular website update and expansion to ensure accurate and useful information
- a budget for the upkeep, maintenance and administration of the Community Burial ground at Llanmerewig.

The number of Council meetings annually has been reduced to 11 (no August meeting) and an on-line banking system implemented to save hours and other costs.

The Council has responded to the latest WG consultation on Local Government and is scrutinising revisions to the much improved Powys Local Development Plan. Current work also includes local resilience to events such as flooding and how our community can best respond in an emergency and support the Powys Emergency Plan.

Next meeting Wednesday 2<sup>nd</sup> March at 1900 at Abermule Community Centre **OIL HEATING** There have been thefts of heating oil from tanks in this area. PLEASE BE EXTRA VIGILANT and report anything suspicious. Also, please remember to fit and lock your tank cap.

**MICROCHIP YOUR DOG** Please remember that legally all dogs in Wales must be microchipped by April 1st. In our area we now seem to have far fewer problems with dog fouling than many other community councils. Thank you to all responsible owners of Abermule; let's keep it that way!
